

## **2021/2022 EGLINTON FLATS WINTER TENNIS CLUB PERMANENT COURT TIME (PCT) APPLICATION**

PCT entitles members to play in their designated time slot each week from October 1, 2021 to April 30, 2022. All cheques are to be payable to **Eglinton Flats Winter Tennis Club**.

Complete a PCT application per group along with membership applications for your entire group. Submit with a current dated cheque/debit card payment/cash/etransfer to [payments@eglintonflats.com](mailto:payments@eglintonflats.com) in full (or a current dated cheque/debit card payment/cash/etransfer to [payments@eglintonflats.com](mailto:payments@eglintonflats.com) with the deposit amount described in "5." below and an August 31, 2021 post dated cheque for the balance) and drop-off at the clubhouse or send to:

**Eglinton Flats Winter Tennis Club will follow the same procedures as last year for members to book permanent court time. All due dates are Sunday May 9, 2021. Priorities 2 to 4 will be allocated on a first come first serve basis. The procedure is as follows:**

1. **Priority 1** will be given to renewing members with existing permanent court time. These members have their PCT reserved for them for next season. This reservation status will be held until May 9th. **Priority 2** will be given to renewing members with existing PCT who would like to change their PCT time, due date is May 9th. **Priority 3** will be given to renewing members seeking PCT, due date is May 9th. **Priority 4** will be given to new members who wish PCT, confirmation will be awarded after June 7th.
2. Prime time hours, non-prime time hours and early bird hours are as described in the 2021/2022 Eglinton Flats Winter Tennis Club Membership Application form.
3. After May 9th any available PCT will be allocated on a first come first serve basis.
4. Applications must list a group contact and all forms must be fully completed and signed.
5. Applications will only be accepted with a NON-REFUNDABLE DEPOSIT cheque/debit card payment/cash/etransfer to [payments@eglintonflats.com](mailto:payments@eglintonflats.com) (minimum **\$640.00 for prime**, minimum **\$350.00 for non-prime**, and minimum **\$270.00 for early bird**) per court hour reserved.
6. Final payment for outstanding PCT fees, if any, must be in the form of an August 31, 2021 post dated cheque. The deposit and balance of the court fees (if any) must each be paid in the form of ONE PAYMENT (cheque/debit card/cash) PER GROUP.
7. Cheques for PCT will be deposited only if PCT is allocated. Members who are not successful with their PCT application, will have their cheques returned to the group leader by mid-August.
8. If you apply for singles your PCT must be used mainly for singles.
9. Regular PCT group players must be members. Guests filling in for members must pay the non-member fee and are limited to being a guest four (4) times during the season. Management reserves the right to cancel the PCT for the entire season for any infraction of this rule.
10. Management reserves the right to reassign PCT groups from one court to another.
