## COVID-19 Pre-Visit Screening and Waiver for Junior Members (DECLARATION

OF HEALTH AND OPERATIONAL COMPLIANCE AGREEMENT)

First Service Tennis Management Inc. ("Eglinton Flats Winter Tennis Club" or "EFWTC" or "the Club") appreciates and expects your partnership and cooperation in complying with the opening guidelines and social distancing protocols established by the Ontario Government. Eglinton Flats Winter Tennis Club is requesting that your child follow our EFWTC COVID-19 Rules and Procedures for operating under COVID-19 restrictions. The Club is permitting members to access the facilities and play tennis at the Club based on the assurances members and the parents/guardians of junior members make to the Club and to each other in this Declaration and Agreement. Accordingly, any false statements made in this Declaration and Agreement or any failure to comply with the requirements detailed below may lead to disciplinary action including, without limitation, restriction or suspension of your child's membership privileges.

As you are aware, COVID-19 can be transmitted by asymptomatic persons. Consequently, the statements made by members and the parents/guardians of junior members contained in this Declaration cannot provide certainty that the virus will not be transmitted. The Club is taking prudent steps to impose and enforce appropriate protocols to keep members safe, but there can be no assurance that the virus will not be contracted by members while at the Club. This is a risk that the parent/guardian of each junior member must assess themselves, and if they choose to have the junior member use the Club facilities and play tennis at the club, each junior member and

parent/guardian will be voluntarily assuming the risk of either contracting the virus or transmitting it to others.

- 1. I hereby declare that I have read, understand, and agree to have my child abide by EFWTC's COVID-19 Rules and Procedures, and for use of the Club's facilities, posted on the Club website and updated from time to time as communicated by the Club. I waive any rights to have my child visit the Club, use its facilities, and play tennis at the Club if my child fails to comply with these policies.
- 2. I hereby declare that neither I nor anyone in my household or my child's household has experienced any of the COVID-19 symptoms identified by Public Health Ontario, in the last 14 days, including without limitation:
  - Fever
  - Cough that is new or worsening
  - o Shortness of breath, unable to breathe deeply
  - Extreme tiredness that is unusual, lack of energy
  - Headache that is unusual or long lasting
  - o Runny, stuffy, or congested nose not related to seasonal allergies
  - Sore throat or difficulty swallowing
  - New loss of sense of taste or smell

- Falling down often
- Muscle aches or chills
- Pink eye (conjunctivitis)
- Digestive issues such as nausea, vomiting, diarrhea, or stomach pain

I agree that if I or anyone in my household or my child's household experiences any of these symptoms after submitting this Declaration, my child will then not visit the Club, nor will I permit any of my household or my child's household to visit the Club, for a minimum period of 14 days after these symptoms have completely gone away.

- 3. I hereby declare that neither I nor anyone in my household or my child's household has had close contact (less than 2 metres physical distance) with someone within the last 14 days who has been diagnosed with COVID-19 or who has experienced symptoms of COVID-19. I agree that if I or anyone in my household or my child's household has had close contact (less than 2 metres physical distance) with such a person after submitting this form, I will then not visit the Club, nor will I permit any of my household or my child's household to visit the club for a minimum period of 14 days after the date of close contact with the individual with COVID-19 or COVID-19 symptoms.
- 4. I hereby declare that neither I nor anyone in my household or my child's household has returned from travelling anywhere outside of Canada in the last 14 days. If I or anyone in my household travels to anywhere outside of Canada after submitting this form, I will then not visit the Club, nor will I permit any of my household or my

- child's household to visit the Club, for a minimum period of 14 days after the date of return to Canada.
- 5. I agree that on every occasion that my child attends the Club after the date of this Declaration and Agreement, I will record my child's attendance by having my child's name listed as one of the players on the tennis court (includes regular court bookings, PCT, lessons, clinics, Junior Academy, and club programs such as round robins, house league, tournaments or any other special event) or by paying my child's share of the court fees using Interac debit or Interac etransfer or cheque. I agree that every one of my child's recorded attendances at the Club will constitute my confirmation that at the time of each attendance at the Club all of the statements in this Declaration and Agreement continue to be true.
- 6. I acknowledge that COVID-19 can be transmitted by asymptomatic people, and that there can be no assurance given by the Club that my child will not contract COVID-19 while visiting the Club, using its facilities, and playing tennis at the Club. Accordingly, I agree that in electing to have my child access the Club's facilities and play tennis at the club, my child and I are voluntarily assuming the risk that either one of us may contract COVID-19 while at the Club.
- 7. I hereby, personally, and on behalf of my child who is a junior member, expressly waive and release any and all claims against EFWTC together with its officers, directors, administrators, servants, agents, representatives, and their successors and assigns (collectively the "Releasees") which I and my children have or may in future have for damages arising out of contracting COVID-19. I, personally, and on my child's behalf, agree not to make or bring any such claim against the Club or any other Releasee, and forever

- release and discharge the Club and all other Releasees from liability under such claim.
- 8. The terms that I have agreed to in this Declaration and Agreement will remain in effect until EFWTC declares that the requirements in this Declaration are no longer in effect.
