5. If you apply for singles your PCT must be used mainly for singles.
6. The PCT court allocations will be accepted in the following order:

Priority	Group	Deadline
01	Renewing members with existing PCT	April 30, 2023
02	Renewing members with existing PCT requesting to change PCT day/time	April 30, 2023
03	Renewing members not having an existing PCT	April 30, 2023
04	New & renewing members on first come first serve basis	June 15, 2023

7. Applications will only be accepted with a NON-REFUNDABLE DEPOSIT of 50% of the total PCT value per court hour reserved or full payment for each court hour of PCT.
8. Payments are accepted only through the group leader and if any refunds are processed due to any form of club closure/resale of courts will be refunded to the group leader.
9. Payments can be made via a cheque, debit card, cash or e-transfer. All cheques are payable to **Eglinton Flats Winter Tennis Club** and e-transfers to [payments@eglintonflats.com](mailto:payments@eglintonflats.com). If the payment is a 50% deposit or a full payment, it needs to be current dated.
10. Final payment for outstanding PCT fees, if any, must be in the form of an August 31, 2023 post-dated cheque. The balance of the court fees (if any) must be paid in the form of ONE PAYMENT (cheque only for balance) PER GROUP.
11. Cheques for PCT will be deposited only if PCT is allocated. Members who are not successful with their PCT application, will have their cheques returned to the group leader by mid-August.
12. Regular PCT group players must be members. Guests filling in for members must pay the non-member fee and are limited to being a guest four (4) times during the season. Management reserves the right to cancel the PCT for the entire season for any infraction of this rule.
13. Our court timings will be staggered. Courts 1-3 are on the hour and courts 4-6 are 10 minutes after the hour.
14. Management reserves the right to reassign PCT groups from one court to another.

We will attempt to give you your preferred choice but cannot guarantee due to the demand for PCT.
